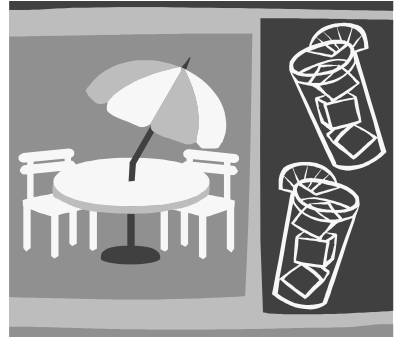

Rebecca Goss was killed instantly in an automobile accident in upper Rancho Cucamonga on March 3rd. This young sixteen year life was quickly snatched away from the John and Martha Goss family. The loss of this sweet, vivacious, young girl who everyone knew as “Becca Boo” affected not only her family but her many friends, neighbors and acquaintances.



There are so many mementos in Becca’s room - her first drawings, art, photograph albums, school work, poetry she had written and loved. On a hook was her western hat which had traveled endless hours and many miles with her and had been filled with autographs and final wishes from pallbearers and family members. Her parents had lovingly saved so many precious memories of every phase of her life.

Becca’s love for

horses came naturally, as her Mother continued to ride while pregnant with Becca. Once Becca was big enough, she was in the saddle as well and continued to ride, love horses, and the sport of riding throughout her short life. Becca taught youngsters to ride horses with her first priority being “safety by the rider and for the horse”.

one was a stranger for long once they met Becca. She instantly loved everyone and everyone loved her.

Our hearts go out to the Goss family and they will always remain in our thoughts and prayers for the loss of this beautiful young lady whose life and dreams were taken away too early. Although we know God must have had a purpose for her, it does not change the pain that is felt by everyone and the days of loneliness without her.

CITIZEN ON PATROL 12TH ANNUAL PANCAKE BREAKFAST - A RESOUNDING SUCCESS!!

The San Antonio Heights-Mt. Baldy Citizen Patrol held their twelfth annual pancake breakfast on Saturday morning, May 26. It was a resounding success with over 740 breakfasts served during a three-hour period; by far the largest crowd ever in attendance.

Attendees were treated to sausage, pancakes, scrambled eggs, coffee, milk, and orange juice. A number of dignitaries assisted in the cooking including Sheriff Department Deputy Chief Sheree Stewart, Captain Rick Carr, and Deputy Matt Griffith and CHP Captain Lynn Jones. The Explorers from Chino Hills and Boy Scout Troop 614 of San Antonio Heights were extremely helpful in the set-up and take-down of tables, chairs, and shades; in cooking eggs; and serving of beverages.



A number of displays were available including Station 12's fire engine, San Antonio Water Company, Fire-Safe Council and the San Antonio Heights Association, the Citizen Patrol, and the Lemonheads from our

local Çadette Girl Scout Troop who sold Luminaries raising funds for the American Cancer Society's Relay for Life.

The Patrol is extremely grateful for donations received: 90 dozen eggs from Shelton's Turkey Ranch; sausage provided at cost by Cask N Cleaver; funds from the San Antonio Heights Community Church and numerous individuals; use of the grill by the Montclair Fire Department; equipment, tools, and labor provided by George Lee; pancake syrup from Albertson's; and the numerous hours donated by various volunteers.



The most wonderful thing about the breakfast is neighbors visiting neighbors; for some, this is about the only time they see each other.

The Team's goal is to educate all residents of the steps they can take to create a *fire safe* landscape and to make available outside resources to answer any questions they might have.

Bill Peters, Information Officer at the Resources Agency Department of Forestry and Fire Protection/San Bernardino Unit, talked with residents. Officer Peters will be available to assist the Fire Safe Council Team as they proceed with furthering the education to keep San Antonio Heights *FIRE SAFE* this season. A Homeowner's Guide to Fire Safe Landscaping (explains how to create a fire safe landscape in seven steps and also cautions residents of things that will endanger a home if even just an ember landed on a little pile of flammable material and how and what to avoid having around).

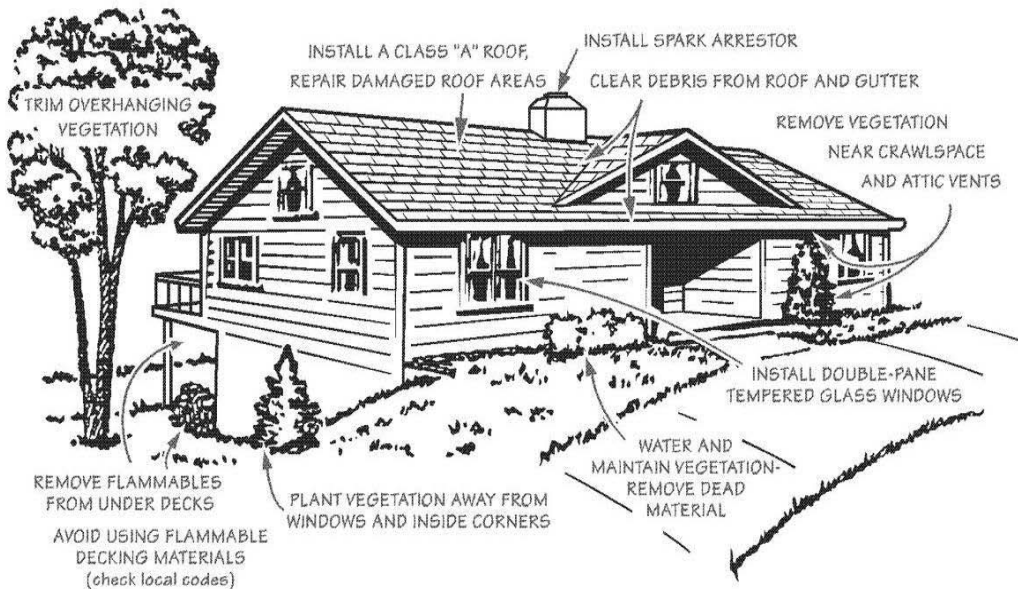
In September members will begin the process to request grants to help fund the possibility of removal of weeds, debris, trees and shrubs from non-resident areas.

If you have become a resident since then and do not know there were eleven homes destroyed in that fire, and only a few of those residents have completed the rebuilding of their homes.

PROTECT YOUR HOME FROM WILDFIRE



Get Ready for Fire Season Get Defensible Space



Homes with defensible space have a much greater chance of surviving a wildfire than homes without!

We at the San Antonio Heights Fire Safe Council encourage you to give your house a fighting chance during a potential wildfire by establishing your defensible space.

Defensible space breaks up the continuous path of plants that could carry wildfire to your home and it gives firefighters a safe zone from which to fight a wildfire. It is worth your effort!

Defensible Space: You can do it

- Remove all flammable vegetation around all structures. State law requires a minimum of 100 feet clearance, but check with your insurance agent to see if your carrier requires more. For more information about state law, contact your local fire department.
- Trim trees so branches are six feet from the ground and 10 feet from your chimney. Remove branches overhanging your roof.
- Call your utility company for help with trees near power lines. Never trim these yourself.
- Remove any dead trees.
- Cut weeds and dead grasses six inches or shorter.
- Always work early in the morning and make sure your power tools have spark arresters to prevent equipment-caused fires.
- Ask your local nursery about landscaping with beautiful, fire-resistant plants.
- Maintain defensible space by clearing up plant litter and watering properly.

Fire Safe Inside and Out Homes with defensible space have a much greater chance of surviving a wildfire than homes without!

We at the San Antonio Heights Fire Safe Council hope you'll agree your future happiness is worth this effort. We encourage you to make your home fire safe, side and out- it could be a lifesaver.


Fire Safe Outside: You can do it

- Clean dead leaves and needles from your roof and gutters.
- If you're reroofing, follow your fire department's current fire safe roofing standards.

- Cover your chimney outlet and stovepipe with non-flammable ½” mesh screen.
- Enclose the underside of eaves, balconies and decks with fire resistant materials to keep out flying embers.
- Stack woodpiles at least 30 feet from all structures.
- Locate LPG tanks at least 30 feet from any structure; maintain 10 feet of clear space around the tanks.
- If you’re replacing windows, install only dual- or triple-paned windows.
- Establish defensible space.

Fire Safe Inside: You can do it

- Install smoke detectors between living and sleeping areas.
- Install smoke detectors in bedrooms if you sleep with the door closed.
- Change smoke detector batteries when changing to daylight savings and standard times.
- Keep a charged, ABC-type fire extinguisher in the kitchen and garage; make sure family members know how to use it

DRY WINTER, FIREWORKS DON'T MIX

An extremely dry winter left our region especially vulnerable to fire this summer, and if you add fireworks to the mix, the danger grows exponentially.

That's why I am urging residents to leave the fireworks shows to the professionals this 4th of July. There are many safe and organized fireworks events planned in the Second District and throughout our County where you and your family can enjoy the sights and sounds of a traditional Independence Day celebration.

As you probably know, all fireworks are illegal to sell or use in unincorporated areas of San Bernardino County, and only a handful of cities still allow the sale and use of "Safe and Sane" fireworks, such as sparklers and other non-aerial pyrotechnics approved by the State Fire Marshall.

Dangerous fireworks such as bottle rockets and Roman candles are illegal to possess or use anywhere in the State of California, but unfortunately, people have found ways to smuggle these dangerous fireworks into our state.

San Bernardino County has clamped down on one of the main routes used to funnel illegal fireworks into the state from Nye County, Nevada. The fireworks are legal in Nye County, but once they cross the state line, it's another story.

Members of the San Bernardino County Sheriff's Department Arson and Bomb Detail along with County firefighters and others regularly stage checkpoints along the highway leading from Nye County to Baker. Sometimes they catch people smuggling a few bags of illegal fireworks. Sometimes they stop people carrying truckloads of pyrotechnics that were more than likely intended for sale in our state.


People caught with illegal fireworks face criminal prosecution that can lead to hefty fines or jail time. An ordinance adopted by the Board of Supervisors last year also requires violators to pay for the disposal of their pyrotechnics.

I hope you and your family enjoy a safe and organized fireworks display this 4th of July.

Bob has seen the Heights change dramatically over the years. More residents, new houses replacing groves, a bit more traffic, but the Heights is still occupied with wonderful, friendly, and helpful people. "You can't beat that for the quality of life up here" he said.

Bob has served as a board member with the San Antonio Heights Association since 2002. During his service with the Board Bob has served as Chairperson for the Historical Society and the Produce Exchange.

Where Are The Recycle Bins?

Many San Antonio Heights residents were asking this question when the recycling bin was missing in May. In April when Albertsons moved to their new location in The Colonies, they canceled the Burrtec services at the old location north of 24th street. In May, a few days before the Pancake Breakfast, the Association contacted Burrtec to pick up and empty the recycling bins and confusion



began. Because Burrtec had been instructed to pick up ALL trash bins, they made the assumption that meant the recycling bin as well. With a number of phone calls to Burrtec and Tracy Trigg, our former Albertsons manager, the Association was given permission to keep the recycling bins until their lease ends in October. Typically the Association benefits about \$1,000.00 each year from these bins. These funds are used by the Association in its operation and to cover the cost of projects such as putting benches on the trails, dedication plaques, etc.

We encourage everyone to recycle but if you are unable to take your recyclables to the Recycling area, please continue to use the blue recycle bins from Burrtec. Recycling benefits our community as well as everyone.

Our special thanks to Albertsons for their continued support by letting us keep the bins in place for the next few months.

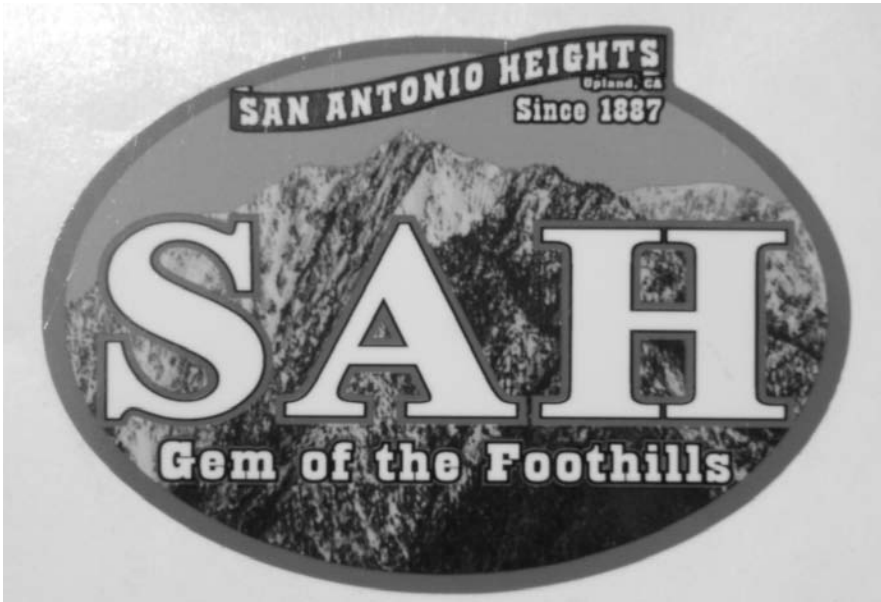

Do you have High Water Pressure?

Did you know having high water pressure in your plumbing system can be damaging and very expensive if not corrected right away?

Not knowing what you're water pressure is, can cost you hundreds and thousands of dollars a year, if it's excessive.

High Water Pressure is defined as; anything over 80 P.S.I. according to the United Plumbing Code. A desirable pressure range is between 45 – 75 P.S.I.

The results of having high water pressure over a period of time are,

1. Causes water heaters, toilets, faucets and hose bibs to leak and constantly need to be repaired or replaced.
2. Causes supply lines and valves to toilets, faucets, dishwashers, icemakers and washing machines to leak and/or burst.
3. Causes main water lines and sprinkler feed lines to leak and/or burst.
4. Causes water hammering and/or squealing sounds in piping systems.
5. Wears out the entire plumbing piping system including appliances such as, water heaters, washing machines, dishwashers and icemakers.
6. Wastes hundreds of gallons of water per year.

Are you currently experiencing any of these problems?

All water leaks can easily be repaired for a reasonable amount of money. But if the leaks are due to high water pressure, your chances increase of a much bigger problem, such as a busted pipe or supply line causing a flood and/or major water damage to your home. Many leaks from high water pressure are actually the water pushing past washers, gaskets and seals in faucets and valves not designed to withstand excessive pressure. Most plumbing materials and faucets are constructed to the more common range of 50 - 60 P.S.I. A water pipe or supply line can burst when the inner walls have been worn away due to the high water pressure, and eventually weakening an area causing it to split open.

Compare your results

45 – 75 P.S.I. Congratulations, you have the desirable pressure range, many water leaks in this range are due to sediment, hard water and normal wear.

80 – 95 P.S.I. Caution, you have excessive water pressure. If you have a water pressure regulator, have it adjusted or replaced. If you do not have one, schedule to have one installed.

100 - 120 P.S.I. Warning, serious leaks and water damage will occur. Have a water pressure regulator installed immediately, if you do not currently have one. If you do have one, it has failed, have it replaced.

Over 125 P.S.I. Extremely Serious, water leaks and damage will occur, same as above and also notify San Antonio Water Company to find out if there may be a problem in the system.

Maintaining proper water pressure to your home, not only saves you money, by reducing water waste and repair costs, it can also prevent you home from major flood damage.

Where is Your San Antonio Water Company Stock Certificate?

Do you know where your Water Company Stock certificate is stored? Do you know if you have the certificate, or if it is being held by your lender? Unfortunately not everyone can answer these questions. Some day when you sell your house, the buyer is going to want your stock, and you will need to produce your stock certificate. If you cannot find your certificate, a lost bond instrument from an insurance company needs to be obtained for about \$350 and a new certificate will need to be issued. This will not happen overnight, and the new certificate must be signed by either the president or the vice president of the Water Board. This process can hold up the sale of a house, and without water stock the sale will not finalize unless the buyer will agree to buy without the transfer of water stock---highly unlikely.



Losing track of your stock certificate is just one of the many problems which can develop regarding ownership of San Antonio Water Stock. A divorce can cause a barrel of problems. If the stock is in the husband and wife's name, both parties must sign the certificate before the certificate can be transferred to another party. If either the former wife or husband refuses to sign, there can be big trouble.

A death of someone who is named as the owner on a stock certificate is usually a fairly easy issue to resolve. It involves showing the necessary documents including a death certificate plus the original stock certificate. A new certificate can then be issued. Unfortunately, a lot of people do not keep all of their important records in one place. Trying to find a water stock certificate is often a frustrating experience for the survivors of someone who has died.

The Water Company has a lot of stories regarding stock certificates. Most center around ugly divorces. Hopefully a divorce is not in the future of anyone living in San Antonio Heights, but if your stock certificate is not in a safe place with other important documents, you might want to consider tracking it down and putting it with these other records. If you are having trouble finding your stock certificate, I would recommend contacting the Water Company to see if the Company's records indicate the stock certificate was sent to your lender.
