Had the entire community been planned for it, an area with 15,000 square foot lots could certainly be made to be desirable. The Heights however as it now exists cannot be redeveloped in this way without being forever disfigured.

### A WORD OF CAUTION......FAKE JURY DUTY CON

Jury duty may be a pain—but, the new fake jury duty scam is worse. The con begins when you receive a phone call, supposedly from your local court. The caller says that a warrant has been issued for your arrest because you have failed to report for jury duty.

Flustered, you protest that you weren't notified—this must be a mistake! Not to worry, says the helpful caller; I just need your Social Security number and date of birth to check our records. You provide that information—and the scammer has what he needs to steal your identity.

Real courts usually correspond by mail, not the telephone. And they don't need your Social Security number—just your name and address should suffice.

Always be cautious....never give out your social security number to someone who calls you... get their number and call back if they are legitimate.

### FOR SALE: THE SAN ANTONIO HEIGHTS WE LOVE

A "For Sale" sign posted on a neighboring home on your street used to mean nothing more than a farewell to some old neighbors and an opportunity to meet some new ones. Now, with property values increasing dramatically and real estate investors multiplying, a "For Sale" sign can mean a radical change in the layout of your street, and the eventual elimination of the views, space, privacy, elegance, culture, and history that for decades have characterized the San Antonio Heights we love.

Currently, any property over 30,000 square feet can be subdivided with nothing more that a rubber stamp from the county. A chief method of dividing single-home properties is the creation of "flag-lots."

"Flag-lots" are a way of subdividing a residential lot that essentially was never meant to be divided. The result is the insertion of an extremely large, multi-story, cube-shaped house in what was originally planned to be the backyard of a single family residence. The towering new house is perched on top of truckloads of fill dirt brought in to maximize the view value and profits for the real-estate speculator. Views from existing surrounding homes are blocked. A common driveway is extended to the back (the "flag-pole"). Problems are many: drainage, water use, view blockage, privacy invasion, light, noise, confused traffic patterns and an overall disruption of the character and history of a street and neighborhood. "Flag-lots" benefit only real-estate speculators and create a compromised situation for everyone else including the buyers of the new home who unknowingly move into a severely disrupted neighborhood. The result is a reduction in quality of living and property values for all. In recognition of the urgency of this issue, the San Antonio Heights Board of Directors voted unanimously on January 26, 2006 to stand in opposition to the creation of "flag-lots" in San Antonio Heights.

Over the years, San Antonio Heights has benefited in many ways by the addition of responsibly planned new homes. But, "flag-lots" are a disservice to everyone including the responsible builders and planners who historically have considered the impact of their building on the community.

If we do not want the permanent future character of San Antonio Heights to be determined by a handful of small-time real estate speculators, then we all need to make our voices heard.

### **BIOGRAPHY OF OUR NEW PRESIDENT**

Ken was born in Pasadena, California and moved to Upland in 1974 when Upland was still mostly orange and lemon groves above Foothill Boulevard. He attended Sycamore Elementary (5th - 6th grades), Pioneer Junior High, Upland High School and Cal Poly Pomona.

Ken's first job was at age 10 for Fred Dundas changing out old smudge pots for new and replacing wicks. Fred helped Ken get started in his first business at age 11 when he gave him ten smudge pots to convert into mailboxes. He cleaned and painted the smudge pots and installed a mailbox on top and then went door-to-door selling them in the new tracts of houses that were being built in Upland.

Ken's second adventure into employment came when he found several old beehives in the lemon grove behind his house and he decided to research how to start bee keeping. His grandfather bought him his first bee colony and he began bee keeping and selling local honey door-to-door. He eventually ended up with five hives and all the honey sales he could handle.

When Ken first moved to Upland and had not yet made new friends, he would ride his bike three blocks to Cable Airport where Dewey Cable, the owner, would stop him and warn him not to ride his bike on the airport property around the airplanes. After being caught many times, Dewey Cable became frustrated and offered him a part time job pulling weeds and picking up trash in the parking lot and around the tie down area. Eventually Dewey offered

money to pay for all of his flying lessons so he became a bus boy at the New China Restaurant on Foothill just south of Cable Airport.

Ken learned to fly at Cable Airport and became a flight instructor while still in high school. He was also towing advertising banners with an antique Stearman Biplane out of Chino Airport to build flying time. His dream became a reality when he became a corporate pilot and flew for many companies in Southern California. He was hired by American Airlines in 1989 and is currently flying the Boeing 777 to London and Tokyo.

Ken bought his first home on 25th Street in San Antonio Heights in 1986. He immediately became active in community affairs mainly with regard to San Antonio Water Company and low pressure and failing infrastructure issues along West 25th Street and south to Mesa Terrace. He was nominated to the San Antonio Heights Association Board in 1991. He has served the Heights Association on the following committees, Gazette Newsletter Editor, Community Cleanup, Water and Legal, Fire and Safety and the Trails Committee.

Ken, his wife, Lindsey, and four children are in the process of rebuilding their house on 26th Street that was destroyed during the Grand Prix Fire in 2003.


### **EQUESTRIAN / HIKING / BIKING TRAILS**

The future of the San Antonio Water Company is hopefully entering a positive period of time. I am writing this article prior to the San Antonio Water Company's Annual Shareholders Meeting, so I am assuming nothing unexpected was reported at the Shareholders Meeting.

The budget for 2006-2007 is filled with many capital improvement projects. Some will benefit the City of Upland, and some will benefit the residents in San Antonio Heights. With a new manager, Charles Moorrees, at the helm, many improvements to our water delivery system which have been delayed for years are now at the top of the list. Before the end of the year, residents of San Antonio Heights will likely see equipment installing new water mains, and much-needed additional fire hydrants.

If you are wondering about the price and availability of water stock, the news is not good. The price of stock continues to climb, and the availability continues to decline. The San Antonio Water Company is aware of the problems regarding the lack of available stock, but so far no one seems to have a good resolution to the problem of limited water stock. If something changes regarding the rules of stock ownership or the availability of water stock, I will do my best to keep you informed of these changes.

# BETTY D. GOTT, LONG TIME RESIDENT PASSED AWAY DECEMBER 20, 2005

Betty D. Gott, born in Clever, Missouri, a resident of Ontario, Upland and San Antonio Heights

for the past 53 years (40 years in the Heights) passed away December 20, 2005 after an eighteen month battle with cancer. She was survived by her husband, Wallace, two sons, Michael of Upland and Terry of Victorville, a daughter, Connie of Upland, seven grandchildren, eight great-grandchildren and many other extended family members and friends. She was a member of San Antonio Heights Community Church. She and her husband, Wallace, founded W.D. Gott Construction Company and had worked side by side since 1956.

Betty and Wallace bought the "old market" where Albertsons is now. It had a gas pump in front and was very small. They had planned to build a new store but the old building was destroyed



by fire, which caused the need for a new building to be built sooner than planned. Arthur and Helen Crieger operated the market with a lease from the Gotts. After a period of time they subleased to someone else that was not successful for about a year. The Gotts bought the full inventory and stocked the shelves in about 1968 and Betty operated the market with a full time meat cutter for about two years. The market including the real estate was sold to Jim Maestra. Betty's daughter, Connie, recalls going to the store and buying candy for a nickel and also that it was the place where the kids from the area would hang out. The San Antonio Heights Market was replaced by Lucky's Market.

Betty is desperately missed by her family and friends.

### CITIZENS ON PATROL VOLUNTEERS ARE DEPUTIES' EYES



San Antonio Heights Citizens on Patrol (COP) volunteers have been the eyes and ears of sheriff's deputies in the community for 11 years.

These dedicated and trained volunteers patrol

San Antonio Heights and Mt. Baldy regularly in marked vehicles and report any suspicious activity they see to the Sheriff's Department. COPs don't carry guns or handcuffs, but their mere presence in the community helps deter crimes such as graffiti and illegal dumping.

COP volunteers also perform a number of other valuable community services including welfare checks on residents, traffic control for accidents, and vacation checks to make sure people's homes remain secure while they are away.

Peter Cherbak, Ben DeFrank, Evelyn Flake, Betty and Cecil Garrison, Cal and Nita McElwain, Ken McNeil, Austin Olinger, Mike Pompa, Robert Shannon, Bob Stinnett, Richard Trigiani and Pam Yokley (now McNeil) started the community's COP program, which now has more than 30 active members.

### The Committee's Goals are:

- 1) To set up and write a Mission Statement;
- 2) To determine Goals and Objectives;
- 3) To break the SAH area into sections and divide committee members into teams. Members will investigate and determine the history here, whether it is structure or an event. This will help us as we try to get structures or areas designated historically and help everyone get a strong perspective of the SAH history.
- 4) To use the Produce Exchange as a history and agriculture festival and to showcase our place in history and our areas' agriculture.
- 5) To create a "Heritage Awards Program" where, we as a group, present an award for a "Structure, Neighborhood or Point of Interest" annually. A special honor in our community at an annual ceremony, such as, the SAHA Annual Meeting, would benefit our community as follows:
  - Strengthen our areas' position as a historic area of district.
  - Encourage the greater community to become involved in our area's history.
  - Create a history program we can build upon in the future, as we seek to designate houses or areas at the state and federal level.
- 6) To add to the following already identified homes and structures as historic designations:
  - The Stone Power castle
  - The Tay's House
  - Stuart Lyman's House
- 7) To have local fundraisers such as:
  - Walking tours of San Antonio Heights
  - Home tours of historical homes

### San Bernardino County Fire Station #12

In December, Chief Thom Wellman was transferred to the San Bernardino County Fire Departments' Valley Division from the Mountain Division. Chief Wellman was welcomed at the SAHA Annual Meeting in November where he had an opportunity to meet and talk with residents in attendance. We look forward to future interactions with Chief Wellman.

We also welcome Captain Bryant O'Hara (replacing Captain Jerry Abshire) and fire fighters Ted Alten and Brian Coale. Captains Siciliano and Shipway are happy to be remaining at Station #12.

The new brush engine is in service and the crews have begun full training. This engine is much more efficient and will better meet the needs of our community. It was recently deployed for the Sierra fire in Orange County and was fully utilized for three days.

A new vehicle exhaust ventilation system has been installed. This system attaches directly to the exhaust pipes on both engines when they are in the bays (garages). It extracts the exhaust and vents it through the roof where it can dissipate rather than invade the living/working areas of the station.

Station #12 has also completed the installation of the new generator. This system is fully automated and assures that the station and radio dispatch system can continue to function without delay during a power outage. The generator was used for the first time during the most recent power outage in the Heights. It worked perfectly!

Cooking for many will be much easier now that the station has a commercial type oven/stove unit that was donated in great condition. Financial donations are always welcome and could be put to good use in upgrading the rest of the kitchen and living areas.

The entire crew at Station #12 would like to thank all of you for your continued support and are looking forward to another year of serving the San Antonio Heights community.
